

Budget Highlights

On March 23, 2022, Lennox & Addington County Council approved the 2022 budget, totalling **\$88 million** in order to provide a broad range of services. Some highlights include:



\$934,300 for capital repairs, equipment and furnishings for **The John M. Parrott Centre** and \$566,100 for **capital improvements to County-owned buildings.**



Expansion of the **Community Paramedic Program** as well as continued service enhancements to **Paramedic Services** at the Stone Mills base.



\$13.8 million for capital improvements to County Roads & Bridges including the reconstruction of County Road 12 from Buttermilk Falls Road to Glenn Elm Road; 8.9 kms of hot mix paving and 22.3 kms of surface treated roads. The County will receive \$1.36 million in federal gas tax funds and \$1.5 from the Province to assist with the cost of road projects.



\$4.0 million for **capital improvements to Community Housing**, including the construction of 8 new units in
Stone Mills. **\$50,000** funding for Lennox and Addington
Affordable Housing initiatives.

Staffing enhancements at **The John M. Parrott Centre** that will further augment our infection control capacity as well as helping to achieve our 4 hours of care and customer service excellence.


\$75,000 per year for a ten-year period (from 2019 to 2028) for the University Hospitals Kingston Foundation capital campaign.

\$25,000 per year for 3 years (from 2020 to 2022) to help support the Lenadco Access Clinic.

What your Property Tax Dollars Support

The average residential property assessment in the County of Lennox and Addington in 2022 is \$257,068 (2021 - \$255,572). The County portion of the property taxes on this assessment in 2022 is \$1,383.66 (an increase of \$44.03 from 2021).

The following summary provides a breakdown of the tax dollars levied by service area from the \$1,383.66 in County property taxes in 2022 on an average residential property of \$257,068.
